When the weekly average U.S. On-Highway Diesel Fuel Price as provided by the Department of Energy (D.O.E.) equals or exceeds \$1.15, an additional charge of (BELOW) will apply:

- A. The weekly average U.S. On-Highway Diesel Fuel Price effective each Monday and the Fuel Surcharge Index Table herein shall be used to determine the fuel surcharge effective Tuesday of that week (or the next business day in the event of a holiday). Contact the Department of Energy at 202-586-6966 for the current weekly diesel fuel price.
- B. A fuel surcharge shall be added to all net linehaul rates and charges as applied by Carrier on all shipments, and determined by using the following Fuel Surcharge Index Table:
